THIS REPRESENTED 3,215 NIGHTS OF HOUSING (95% OCCUPANCY). IN OUR HOSPITAL-BASED PROGRAMS, STAFF AND VOLUNTEERS SERVED OVER 18,000 FAMILY MEMBERS. VOLUNTEERS AND STAFF VISIT FAMILIES AT THE CHILD'S HOSPITAL BEDSIDE, BRINGING BEVERAGES, A LISTENING EAR AND WELCOME CONVERSATION.
